- 1. Article II, Dimensional Regulations, Section 2a. shall be amended to read as follows: "Any lot created in the Town of Springport shall have a minimum area of 40,000 square feet, with a width of not less than 150 feet, to meet the requirements for installation of water and sewer systems to serve the uses to occur upon said lot and to meet any requirement of this or other Laws regarding the sighting of structures, provision for parking, landscaping, buffering from adjacent uses, and similar dimension requirements." The requirements for water and sewer installation shall be those of the Cayuga County Health Department or other Agency having jurisdiction over such matters.
- 2. Amend Article III, Use Regulations, to add Section 4b.
