SECTION 1

The maximum income eligibility level for a partial Town tax exemption for persons 65 years of age or over which is now set at \$8,000.00 is hereby modified to increase the maximum eligibility level pursuant to and in accordance with the exemption being based on the maximum annual income range specified in the following schedule:

<u>INCOME RANGE</u>	<u>PERCENTAGE OF EXEMPTION</u>
1. \$ 0 to \$8,000	50%
2. \$8,001 to \$8,499	45%
3. \$8,500 to \$8,999	40%
4. \$9,000 to \$9,499	35%
5. \$9,500 to \$9,999	30%
6. \$10,000 to \$10,499	25%
7. \$10,500 to \$10,999	20%
8. Over \$10,999	0%

The maximum income eligibility level of \$8,000.00 as set forth in Local Law #2 of 1984 is hereby modified pursuant to and in accordance with Section 467 of the Real Property Law.

The percentage of exemption shall be based on the maximum annual income range specified herein as follows:

1. \$ 0 to \$ 9,000	50%
2. \$ 9,001 to \$ 9,499	45%
3. \$ 9,500 to \$ 9,999	40%
4. \$10,000 to \$10,499	35%
5. \$10,500 to \$10,999	30%
6. \$11,000 to \$11,499	25%
7. \$11,500 to \$11,999	20%
8. Over \$11,999	0%
