LOCAL LAW NO. 1 FOR THE YEAR 2003

A LOCAL LAW AMENDING CERTAIN LOCAL LAWS TO ADJUST THE INCOME RANGE FOR PARTIAL TOWN REAL PROPERTY TAX EXEMPTIONS UNDER SECTIOS 467 AND 459-c OF THE REAL PROPERTY TAX LAW.

BE IT ENACTED by the Town Board of the Town of Springport, County of Cayuga, New York, as follows:

Section 1: In accordance with Chapters 198 and 222 of the Laws of 2001, the following sections of the following listed Local Laws are hereby amended:

<u>Section</u>	<u>Local Law</u>
1	Number 1 for the year 1995

Said section is hereby amended to adjust the maximum annual income range for partial real property tax exemptions for persons of the age of 65 years or over and others eligible pursuant to and in accordance with Section 467 of the Real Property Tax Law and for persons with disabilities and others eligible who have limited incomes pursuant to and in accordance with Section 459-c of said Law.

Section 2: The above referred to amended income ranges shall be as specified in the following schedule with regard to both of the said exemptions:

<u>INCOME RANGE</u>	<u>EXEMPTION PERCENTAGE</u>
14,800 or LESS	50%
MORE than 14,800 but LESS than 15,800	45%
15,800 or MORE but LESS than 16,800	40%
16,800 or MORE but LESS than 17,800	35%
17,800 or MORE but LESS than 18,700	30%
18,700 or MORE but LESS than 19,600	25%
19,600 or MORE but LESS than 20,500	20%

Section 3: Except as specifically amended by this local law or any previous local law that is not inconsistent with this local law, the above referred to Local Laws are hereby confirmed and continue in effect.

Section 4: This Local Law shall take effect in accordance with the Municipal Home Rule Law.

Section 5: This Local Law shall take effect immediately upon its filing with the Secretary of State of the State of New York.
