Pursuant to the Real Property Tax Law, Section 512, Local Law #1 of the year 1993 is hereby amended to provide that the date for the meeting of the Board of Assessment Review for the Town of Springport is hereby changed from being the fourth Thursday of the month of May of each year to the new date which shall now be the first Thursday following the fourth Tuesday of the month of May each year.

This Local Law shall be in effect for the year 1997 and for all subsequent years until it shall be changed by this Board or by the New York State Legislature.

This Local Law shall take effect as soon as it has been filed with the appropriate offices of the State of New York.

A local law to amend Local Law No. 2 of 1991 (Town of Springport Zoning Law)

of Springport as follows:

1. Article II, Dimensional Regulations, Section 2a. shall be amended to read as follows: "Any lot created in the Town of Springport shall have a minimum area of 40,000 square feet, with a width of not less than 150 feet, to meet the requirements for installation of water and sewer systems to serve the uses to occur upon said lot and to meet any requirement of this or other Laws regarding the siting of structures, provision for parking, landscaping, buffering from adjacent uses, and similar dimension requirements." The requirements for water and sewer installation shall be those of the Cayuga County Health Department or other Agency having jurisdiction over such matters.

2. Amend Article III, Use Regulations, to add Section 4b. New or used Mobile Homes or House Trailers must be less than two (2) years old, certified as meeting the current H.U.D. standards and found on inspection to be in excellent condition, safe and fit for residential occupancy as determined by the Town Zoning Officer.
