CALL TO ORDER: The meeting was called to order at 7:00 pm and opened with the Pledge.

- A. AGENDA:** Mr. Rindfleisch made the motion to approve the Agenda, Seconded by Mr. Selover. Aye, all with no discussion.
- B. MINUTES:** Mr. Selover made the motion to approve February 10th & 19th, 2025, minutes. Seconded by Mr. Rindfleisch. Aye, all with no discussion.
- C. Reports:**

 - 4. Assessor-FL 21 submitted on Feb 28th, the day before taxable status day a request to subdivide all parcels as per the approved map. Jennifer Schenk stated that this will be a huge amount of work and would like to wait until 2026 to complete the subdivisions. FL 21 has also asked the Assessor to appraise the parcels. She let FL 21 know that she is not an appraiser, and they would need to hire an appraiser.

- E. Old Business:**

- F. New Business:**
 - 1. US water rate increase. Supervisor Schenk received a letter from the village stating the water rate increase of \$25 minimum, \$5 per 1000 gallons.
- G. Rural Water Exploration:** From Owasco through Fleming- water district #2 board agreed to explore the possibility, and this would allow us to buy water from the Town of Owasco.
 - a. Lead agency. Mr. Cornell made the motion to be the Lead Agency, Springport Office will complete meter readings, billing and collecting. Second by Mr. Selover. Aye David Schenk, Michael Selover, Loydd Cornell. Opposed Andrew Rindfleisch with no discussion.
 - b. SEQR- Mr. Rindfleisch made the motion to make the SEQR a negative declaration. Second by Mr. Cornell. Aye all with no discussion.
 - c. Mr. Cornell made the motion to hold a public hearing on April 16, 2025 to consider improvements to the Springport-Fleming rural water district. Second by Mr. Rindfleisch. Aye all with no discussion.
- H. Highway Report:** box and repairs for plow truck \$72,395 stainless box. New truck would be about \$310,000. which includes plow. Mr. Walter stated trucks have not been on the 5-year rotation plan in a few years. Mr. Weaver spoke about his experience purchasing trucks.
